Junior Membership

You must be 16 years and over to become a member of The Cancer Support Group. Anyone under the age of 18 is classified as a Junior Member and the membership fee is waived. As a Junior Member you are prohibited to perform admin duties in the office. You are welcome to perform any other tasks within the requirements of a member of The Cancer Support Group.

Senior Membership

As a Senior Member you must be 18 years and over. You are subject to an \$11 annual membership fee and your performance is subject to the Terms and Conditions of this agreement.

Life Member

Life Membership is awarded to individuals who have dedicated years of service to the Group. They have shown extraordinary commitment to The Cancer Support Group, including going above and beyond responsibilities as a senior member.



## **TERMS AND CONDITIONS**

**Following are the terms and conditions of The Cancer Support Group ACT Eden Monaro's Own membership. Benefits and conditions of membership are subject to change and are at the discretion of The Cancer Support Group.**

### **Membership Terms**

- 1. The organisation will not be responsible for any member breaching The Privacy Act or breaking any laws including and not limited to speeding, parking fines and indecent behaviour when representing The Cancer Support Group ACT Eden Monaro's Own.**
- 2. Any legal proceedings against a member of The Cancer Support Group ACT Eden Monaro's Own will not be the responsibility of the Group.**
- 3. Members are required to help with a minimum of 4 functions per year in a working capacity. All members must include Convoy for Cancer Families as one of their nominated functions.**
- 4. Member responsibilities will be scheduled on a roster for functions. If a member is not available they are to arrange with another member to swap responsibilities.**
- 5. It is understood that members are not expected to work at all functions. However The Cancer Support Group has the right to cease membership at any time if you are not fulfilling the basic requirements of the membership terms and conditions.**
- 6. Being a financial member of the organisation requires you to attend at least 6 meetings per year and to send apologies for any meeting they cannot attend. An exception is made for valid reasons that makes this impossible.**
- 7. Members are entitled to voice their opinion on matters raised at the monthly meetings.**
- 8. Members may also ask the President to present to the Board of Directors any suggestions, queries and problems they may have.**
- 9. The Privacy Act requires total confidentiality, any matters (oral or written) relating to the organisation must not be discussed with anyone other than a financial member of the organisation.**
- 10. You have shared responsibility of the future of The Cancer Support Group including voting and nominating the Board of Directors, assistance at functions and positive marketing of the Groups initiatives via social media platforms and word of mouth appraisal.**
- 11. We ask you to notify the Volunteer Coordinator of times you are not available for assistance, such as holidays and prior commitments.**
